ALLEGRO MUSIC CENTRE, INC., hereafter called the Rentor, rents to the above named Customer the above described instrument at and for the monthly rental set forth above, payable in advance each month on the date set forth above, upon the following terms and conditions:

- 1.) Customer agrees to pay the monthly rental promptly when due and to pay a late charge of ten percent (10%) of each monthly rental payment which is not paid within five (5) days after the due date of the payment.
- 2.) Customer agrees to take good care of the instrument and to use it in a responsible manner and to pay all costs of repair if the instrument is damaged in any way.
- 3.) Customer must be a resident of Central Florida and shall not remove or take or allow the instrument to be taken out of the Central Florida area without the written consent of the Rentor.
- 4.) Customer shall be responsible for all loss or damage to the instrument and agrees to pay promptly to the Rentor the replacement cost of the instrument, less the rental previously paid to the Rentor, in the event of the loss, theft or damage beyond repair of the instrument.
- 5.) Customer may terminate this rental agreement at any time by returning the instrument to the Rentor in as good condition as it was at the beginning of this rental agreement, reasonable wear excepted, and paying all rent due on it to date of return.
- 6.) Customer shall have the option and privilege of purchasing the instrument at any time provided this agreement is then in good standing by delivering to the Rentor the sale price above set forth to date of payment of purchase price, less all rental payments paid by the Customer to the Rentor under the terms and provisions of this rental agreement.
- 7.) Rentor may terminate this rental agreement if any rent payment is not paid when due or if the Customer shall violate, fail to perform or be in default on any of the terms and provisions of this rental agreement by giving notice of default to the Customer by delivery or by mail to the address shown on this agreement or to such later address as shall be furnished by the Customer in writing or to the last known address of the Customer, and unless the violation or default shall be remedied or cured by the Customer within ten (10) days from date of delivery or mailing of said notice, then this rental agreement shall be terminated and the Customer shall immediately return the instrument to the Rentor and pay any rental in arrears and the cost of any repairs needed to place said instrument in as good condition as it was at the beginning of this rental agreement, reasonable wear excepted.
- 8.) Customer agrees to pay all loss damage, repossession expenses and other costs, fees and expenses, including reasonable attorney's fees incurred by the Rentor in enforcing Rentor's rights under this agreement.
- 9.) Rentor makes no warranty, express or implied, in connection with this rental agreement or the instrument rented.
